April 2018 marks the official launch of the online version of the Certified JOC Professional (CJP) training program. Due to high demand, CJE is launching a Learning Management System (LMS) for online education and certification. The most recent in-person class at Arizona State University sold out in two weeks and the wait-list keeps growing. We will continue the in-person classes but the option to take the classes online is available in 2018. Please remember that your membership provides you with great discounts on the educational programs.

The new LMS will expedite the submittal for credentialing for those that seek the professional credential (CJP) in addition to the training. The credentialing is being led by the Board of Directors member, Vincent LeMond and the training is being coordinated through the Executive Director, Rhonna Endres.
